Paid Holidays For City Workforce

Below is a schedule of the paid holidays that most city workers will receive in 2010.

The schedule does not apply to prevailing wage employees under contract with the city. They are advised to contact the City Comptroller's Office to find out their paid holidays.

Members of the uniformed forces— except for Sanitation Workers—do not receive Martin Luther King Jr.'s Birthday as a paid holiday. Lincoln's Birthday, Feb. 12, is a floating holiday; employees who wish to take off Feb. 12 must notify their supervisors in writing. The schedule:

- New Year's Day—Jan. 1.
- Martin Luther King Jr.'s Birthday—Jan. 18.
- Lincoln's Birthday—Feb. 12.
- Washington's Birthday—Feb. 15.
- Memorial Day—May 31.
- Fourth of July (observed)—July 5.
- Labor Day—Sept. 6.
- Columbus Day (observed)—Oct. 11.
- Election Day—Nov. 2.
- Veteran's Day—Nov. 11.
- Thanksgiving Day—Nov. 25.
- Christmas Day (observed)—Dec. 24.
- New Year's Day (observed)—Dec. 31.
